# A RESOLUTION OF THE TOWNSHIP OF TYRONE, ADAMS COUNTY, PENNSYLVANIA, PROVIDING AN INCREASE IN THE RETURN CHECK FEES FOR CHECKS ISSUED TO THE TOWNSHIP TAX COLLECTOR

WHEREAS, on March 15, 2017, the Board of Supervisors of Tyrone Township enacted the Codified Ordinances of Tyrone Township, Adams County, Pennsylvania (the "Code"); and

WHEREAS, Chapter 11, Part 6, Section 11-601A of the Code established a Return Check Fee for checks issued to the Township Tax Collector; and

**WHEREAS,** Section 11-601.A.2 provides that the amount of the Return Check Fee may be changed by the Township from time to time by Resolution.

**NOW, THEREFORE**, the Board of Supervisors of Tyrone Township hereby resolves as follows:

## **SECTION I**

Return Check Fee

- 1. Tyrone Township hereby imposes an increase in the Return Check Fee from \$25.00 to an amount not to exceed the actual Return Check Fee charged by the Depositing Financial Institution.
- 2. All fees collected hereunder shall be deposited into the Tax Collector's General fund.

## **SECTION II**

Severability – The provisions of the Resolution shall be severable, and if any provision hereof shall be declared unconstitutional, Illegal or invalid, such decisions shall not affect the validity of any of the remaining provisions of this Resolution. It is hereby declared as the intent of the Township that this Resolution would have been enacted as if such unconstitutional, illegal or invalid provisions had not been included herein.

#### PART 6

## TAX COLLECTOR FEES

## §11-601. Tax Collector Fees.

#### A. Return Check Fee

- 1. Tyrone Township hereby imposes a fee of twenty-five dollars (\$25.00) per check being returned commencing five (5) days after the effective date of this Part.
- By further determination of this Township, this fee shall be set, from time to time, by resolution, in the event Township determines a need to change from the initially established fee.
- This fee will be for any check to any Township office or organization for any purpose.
- Fees concerning checks returned by the Tax Collector shall be deposited to the Tax Collector's General Fund, with other fees being deposited in Tyrone Township's General Fund.

## B. Service Fee Regarding Delinquent Tax Statement

- Tyrone Township hereby imposes a service fee of five dollars (\$5.00) to be assessed to each person, firm or corporation requesting a certification as to the payment status of real estate taxes or a delinquent tax statement from the Tyrone Township Tax Collector's Office.
- By further determination of this Township, this shall be set, from time to time, by resolution, in the event Township determines a need to change from the certification as to the initially established fee.
- Fees concerning delinquent tax statements shall be deposited to the Tax Collector's General Fund.

## C. Tax Duplicate Fee

 Tyrone Township hereby imposes a fee to be assessed to each person, firm, corporation or other entity requesting a tax duplicate from the Tyrone Township Tax Collector. 2. The amount of the tax duplicate fee shall be set by resolution of Tyrone Township from time to time.
