<u>Approval and Payment of the Accounts Payable Invoices, Monthly Bank Run</u> <u>Statements and Credit Card Purchases for March 27 & April 10,2024:</u>

Dashoff made a motion to approve payment of the Accounts Payable Invoices, as well as the payments made in the second check run, the Bank monthly transactions and the credit card purchases of March 2024. Mosley seconded the motion. A vote was taken and it was carried unanimously.

Old Business:

- Resolution 2024-03 was posted to Website.
- _ 3rd Reminder Letter for District 2 was sent out on March 1, 2024. There is appx. 150 residents to be completed by June 30, 2024. It was noted that waiting until last minute could cause backup by the pumper/haulers and not allowing them time to schedule and that they could be late and additional fees might occur.
- Heebner/Weyant Non-building Waiver/Subdivision plans were accepted. Dashoff made a motion to accept the Non-building Waiver for the Heebner/Weyant Subdivision Plans Mosley seconded the motion. A vote was taken and it was carried unanimously and plans were signed.

Liquid Fuels Audit was sent in as accepted and final.

- Painting of the Wastewater Facility- It has been a long time since it was painted as well as noted that it additionally needs repairs. Dashoff made a motion to make repairs and paint the facility, color to be determined. Mosley seconded the motion. A vote was taken and it was carried unanimously.
- Chestnut Hill and Pond Road Reconstruction project discussion was moved to next meeting as more information is needed before final comments can be made.
- Driveway and Street Road Occupancy Ordinance Draft was discussed by Board New Homes
 Constructions are having effects on our current Roads due to bigger, heavier equipment being
 used. Currently there is no enforcement of Township current ordinances. Solicitor Shultis will
 revisit our current Driveway Permit Request to reflect the Driveway Ordinance the Township
 currently has and will be updating our current permit requests for the future
- Truck Terminal and Warehouse Zoning Amendment. Currently another township is dealing with a very large trucking facility possibly being built and residents are concerned. The Township has requested our Solicitor to look at and update our current ordinances so that our residents are protected and would not face similar problems. More discussions will be held in the future. Dashoff made a motion to have Solicitor Shultis look at and present updated/new ordinance. Mosley seconded the motion. A vote was taken and it was carried unanimously.
