MINUTES OF MEETING OF TYRONE TOWNSHIP BOARD OF SUPERVISORS ADAMS COUNTY, PENNSYLVANIA December 15, 2021

The Board of Supervisors Meeting for Wednesday, December 15, 2021 was held at the Tyrone Township Municipal Building, 5280 Old Harrisburg Road, York Springs, PA 17372, Adams County, Pennsylvania.

<u>Call to Order:</u> Raub called the meeting to order at 6:00 PM.

Pledge of Allegiance: Raub led the Pledge of Allegiance.

Approval of Board of Supervisors Meeting Minutes:

Wonders made a motion to approve the minutes for the December 1, 2021 Board of Supervisors meeting. Mosley seconded the motion. A vote was taken and the motion carried unanimously.

Approval and Payment of Accounts Payable Invoices:

Wonders made a motion to approve payment of the Accounts Payable Invoices. Mosley seconded the motion. A vote was taken and the motion carried unanimously.

Organizational Announcements:

- *PSATS Boot Camp:* Mosley and Incoming Supervisor Fitting will be attending the first session of the PSATS Boot Camp for township officials at the PSATS Education Center in Enola, PA tomorrow evening at 6:00 PM.
- *Waste Contract Bid Opening:* There will be a public Bid Opening for the upcoming waste contract tomorrow at 2:15 PM at the York Springs Borough Office. At the mandatory Pre-Bid meeting on December 1, 2021, there were two (2) waste companies in attendance, Waste Management and Waste Connections, so the Township could receive a maximum of two (2) bids for the upcoming contract.
- District 2 Notices of Violation: Fitting has been busy delivering Notices of Violation to District 2 property owners who were not compliant with Ordinance 2016-01 according to the Township's records. He has delivered 80 Notices of Violation so far. The Township has heard from many of these property owners that they complied with the Ordinance, but the Township had not received the reports and administrative fees required of the pumper/haulers to remove these property owners from the Noncompliance List. Mr. Peck and Mrs. Peck-Hays of Peck's Septic Service provided their concerns and suggestions for improvement for the recordkeeping required of Ordinance 2016-01. The Board will consider providing lists of properties in the Township sorted by Districts 1, 2, and 3 to its registered pumper/haulers.

Annual Training and Appreciation Dinner:

Mosley made a motion for the Township's 2022 Annual Training and Appreciation Dinner to be held on Thursday, May 26, 2022 from 6:00 PM - 8:30 PM at Greystone Brewhouse in Dillsburg, PA, and to authorize the Township to pay the \$500.00 deposit. Raub seconded the motion. A vote was taken and the motion carried unanimously.

The developer has been trying to obtain a private meeting with the Board regarding this for months, and the Township has invited them to the Board's public meetings since the Board cannot meet privately.

Postage Printing Services:

Mosley made a motion to establish Pitney Bowes for the Township's postage services moving forward, and to signal to McFadden when to transition to this software. Raub seconded the motion. A vote was taken and the motion carried unanimously.
